# TOY PRODUCT RECALLS

**PRODUCT/FIRM:** "Sky Scrambler" and "The Sharper Image" Wireless Indoor Helicopters by Innovage LLC. **BRAND/MODEL:** The "Sky Scrambler" and "The Sharper Image" toy helicopters have yellow, red or blue



decals. BH26047 is printed on the Sky Scrambler's tail. "The Sharper Image" is printed on the tail. This product was sold at mass merchandisers, department stores, drug stores

and other retail stores nationwide from June 2007 through May 2008 for about \$20.

**PROBLEM:** The rechargeable lithium ion battery inside the helicopter can overheat, catch fire, and ignite nearby combustibles, posing a burn and a fire hazard to consumers.

**REMEDY:** Consumers should immediately stop using the recalled helicopters and contact Innovage at **(866) 672-2630** or visit <u>www.innovage.net</u> for a full refund.

**PRODUCT/FIRM:** Bright Starts Ring Rattles by Kids II Inc.

**BRAND/MODEL:** The soft toy rattle is a bee with a yellow head, ring-shaped green body, blue/green wings



and purple/red antennas. Model number 8534 and date code PA8 are printed on a sewn-in label on the bee's head. This product was sold at toy stores, mass merchandisers and other retail stores nationwide from January 2008 through June 2008 for about \$2 to \$3.

PROBLEM: The tip of the rattle's antenna, which is attached to the bee figure, can detach and pose a choking hazard to small children.

**REMEDY:** Consumers should immediately take the recalled rattles away from small children and contact Kids II at (877) 325-7056 or visit <u>www.kidsii.com</u> to receive a free replacement rattle.

PRODUCT/FIRM: Dowling Magnets

: Classic Horseshoe Magnets by

**BRAND/MODEL:** This recall involves the Classic Horseshoe Magnets. The 6-inch tall horseshoe magnet



has a red plastic coating on the "handle" end. Each "foot" of the magnets has an engraved "S" or a "N." This product was sold at specialty retail stores and educational supply distributors nationwide from March 2003 through April 2008 for about \$10.

PROBLEM: The plastic coating on the magnets contains excessive levels of lead, which violates the federal lead paint

standard.

**REMEDY:** Consumers should immediately take the classic horseshoe magnets away from children and contact Dowling Magnets at **(866) 623-3336** or visit <u>www.dowlingmagnets.com</u> to receive a free replacement horseshoe magnet.

**PRODUCT/FIRM:** U-shaped Magnets, Bar Magnets, Magnet Sets and Magnet Needle Sets by Pacific Science Supplies Inc.

**BRAND/MODEL:** Magnets involved in this recall are "Large" and "Small" U-shaped Magnets in the shape of a



"U" or a horseshoe. One half of each magnet is painted red and is imprinted with the letter "N"; the other half is painted blue, and is imprinted with the letter "S." "Large" and "Miniature" Bar Magnets are in the shape of a bar. The magnets are painted half red

and half white. The red half is imprinted with the letter "N" and the white half is imprinted with the letter "S." The Magnets sets contain a small u-shaped magnet, two small bar magnets and two small compasses. All magnets are painted half red and half white. The red

half is imprinted with the letter "N" and the white half is imprinted with the letter "S." The package is labeled "Magnets & Compasses." The Magnet Needle Sets contain 10 sets of small cone-shaped bases and elongated diamond-shaped magnets which can be fastened into the bases. The magnets are painted half red and half white. Theses products were sold through distributors nationwide that sell to educational institutions. A small number were sold through educational stores nationwide from April 2000 through February 2008 for about \$9.

**PROBLEM:** The paint on the magnets can contain excessive levels of lead, violating the federal lead paint standard.

**REMEDY:** Consumers should immediately stop using these recalled magnets and contact Pacific Science Supplies Inc. at (800) 530-1500 or visit <u>www.pacsciusa.com</u> to receive a free replacement.

**PRODUCT/FIRM:** Stuffed Toy Dogs by Daiso LLC **BRAND/MODEL:** The recalled toys are crème colored stuffed dogs with black eyes and nose. Some of the



toys have brown spots on the back. A tag attached to the toy is written in Japanese language with UPC codes 4947678264166 and 4947678246063. This product was sold at Daiso retail stores in California and Washington State from October

2007 through December 2007 for about \$3.

**PROBLEM:** The stuffed toys contain small parts, posing a choking hazard to young children.

**REMEDY:** Consumers should immediately stop using the toys and return them to any Daiso retail store for a full refund. For additional information, contact Daiso at **(866) 768-4620** or visit <u>www.daisollc.com</u>.

### PRODUCT/FIRM: Wooden Toys by Earthentree

**BRAND/MODEL:** This recall involves a variety of wooden toys including egg shakers (maracas), pull toys, rattles, and trains. The toys are painted glossy red,



orange, green, brown, yellow and natural wood. These products were sold at Earthentree's Web site, fairs, trade shows and retail stores nationwide from December 2007 through

May 2008 for about \$7 to \$34.

**PROBLEM:** The recalled toys contain small parts or can break into small parts, posing a choking hazard. The recalled rattles violate the federal rattle standard. Some of the toys also have a string longer than 12 inches, which can pose a strangulation hazard to young children.

**REMEDY:** Consumers should immediately take the recalled toys away from children and contact Earthentree at (800) 963-1593 or visit <u>www.earthentree.com/recall.asp</u> for a refund or exchange.

**PRODUCT/FIRM:** Learning Pots & Pans<sup>™</sup> Toys by Fisher–Price

**BRAND/MODEL:** This recall involves Learning Pots and Pans<sup>™</sup> toy sets with stackable pots and pans, a lid and shaped-sorting blocks. The toys have a light and



sound feature that operate on three AA batteries. Model number G6685 is located on the bottom of the blue pan. This product was sold at discount department and toy stores nationwide from October 2007 to August 2008 for about \$20.

**PROBLEM:** Missing screws in the blue toy pan can cause the clear come losse and release small balls

plastic cover to come loose and release small balls, presenting a choking hazard to young children.

**REMEDY:** Consumers should immediately take these recalled toys away from children and examine the bottom of the blue pan. The pan should contain six screws. If all screws are installed, no further action is necessary. If any screws are missing, contact Fisher-Price at (888) 521-0820 or visit www.service.mattel.com to arrange for the return of the blue pan for a replacement.

**PRODUCT/FIRM:** Batteries used in Radio-Controlled Helicopter Kits by Hobbico Inc.

**BRAND/MODEL:** This recall involves the Electrifly lithium-polymer batteries (part #GPMP0401) sold individually or with the Heli-Max Axe Cp-L radio-controlled helicopter, a battery, a radio transmitter, a



balance charger, a car adapter, AC wall adapter, decals that read "HMX", "AXE" and "Heli-Max" and training gear. "Electrifly" and "GPMP0401" are printed on the battery. This product was sold at

Hobby Stores nationwide and online from November 2007 through March 2008 for about \$35. The helicopter kits were sold for \$200.

**PROBLEM:** The rechargeable battery can overheat and catch fire while charging, igniting nearby combustible materials. This poses a fire hazard to consumers.

**REMEDY:** Consumers should immediately stop using the recalled batteries and contact Hobbico at **(866) 462-2426** or visit <u>www.elecrifly.com</u> for instructions on returning their battery for a free replacement battery.

**PRODUCT/FIRM:** "Protocol" Remote-Controlled Mini Helicopter Toys by Ashley Collection Inc.

**BRAND/MODEL:** This recall involves the "Protocol" remote-controlled mini helicopter toys with model



numbers starting with 1442. The helicopter is made of foam and plastic and measures about 7 inches long. "Protocol" is printed

on the tail and on the side of the helicopter. "1442-X" can be found on the packaging. The remote-control

component measures 5  $\frac{1}{2}$  inches by 4  $\frac{3}{4}$  inches. This product was sold at retail stores nationwide from October 2007 through December 2007 for between \$30 and \$50.

**PROBLEM:** The rechargeable battery inside the helicopter can overheat. This can result in the helicopter's body melting, as well as a risk of fire or burns to consumers.

**REMEDY:** Consumers should immediately take the recalled toys away from children and contact Protocol at (800) 261-1193 or visit <u>www.protocoldesign.com</u> for information on how to receive a replacement helicopter.

**PRODUCT/FIRM:** MacGregor Folding Soccer Goals Mitre Folding Soccer Goals by Regent Sports Corp.

**BRAND/MODEL:** Both soccer goals have a foldable white frame with a white net that is attached by Velcro



that is attached by Velcro strips. When upright, the MacGregor goal measures 6 feet wide by 3 feet high, and the Mitre net measures 8 feet wide by 6

Each has a recalled net with squares feet high. measuring 5 inches on each side. The MacGregor soccer goal has model number 97236 printed on the instructions and UPC code assembly number 029807972365 printed on the net's packaging. The Mitre soccer goal has model number 89186 printed on the assembly instructions and UPC code number 029807891864 printed on the net's packaging. Nets manufactured after April 2007 with 4 inch by 4 inch square openings are not included in the recall. This product was sold at Wal-Mart, Ace hardware and sports and toy stores nationwide from May 2002 through May 2008 for \$26.

**PROBLEM:** The fixed knot flexible openings in the soccer goal net can pose a head and neck entrapment or strangulation hazard to young children.

**REMEDY:** Consumers should stop using the recalled soccer goal nets immediately and return them to Regent Sports to receive a free replacement net. For additional information, contact Regent Sports at **(877) 516-9707**.

**PRODUCT/FIRM:** Wood Abacus by LTD Commodities LLC and ABC Distributing

**BRAND/MODEL:** The recalled wood abacus is a multisided activity center that has a chalkboard, movable



block letters with pictures, sliding shapes, a fun maze with gears and a blue and yellow clock on the side of the activity center with two pink moving hands. Product code E7A is printed on the packaging near the UPC bar code. This product was sold by LTD Commodities and

ABC Distributing catalogs nationwide and Web site from December 2006 through February 2008 for about \$12.

**PROBLEM:** The wooden rods on the abacus can detach, posing a choking hazard to young children.

**REMEDY:** Consumers should take the abacus away from children immediately and contact LTD Commodities at **(866) 736-3654** or visit <u>www.ltdcommodities.com</u> or

**www.abcdistributing.com** for instructions on receiving a product credit.

**PRODUCT/FIRM:** Harry Potter Bookend by Giftco Inc.

**BRAND/MODEL:** This recall involves poly-stone bookends painted and shaped in the characters of the



Harry Potter book series. Bookend chatacters include Harry Potter, Hedwig and Hermoine, and Crookshank. This product was sold at elementary school fundraising programs, discount and dollar stores nationwide from June 2004 through January 2006 for

between \$3 and \$28.

**PROBLEM:** The paint on the bookend contains excessive levels of lead, violating the federal lead paint standard.

**REMEDY:** Consumers should immediately take the recalled bookends away from children and return them to Giftco for a refund. For additional information, contact **(888) 448-6728** or visit <u>http://mail.giftcoinc.com</u>.

**PRODUCT/FIRM:** Razor® PoweringWing™ Three-Wheeled Scooter by Razor USA LLC

BRAND/MODEL: The PowerWing is a three-wheeled



scooter, which was sold in either black or silver. The recall includes products with serial number beginning with Y708, Y 709, Y 710, Y711, Y712, Y801, Y802, Y803, Y804, Y805, Y806, Y807, and Y808. The serial number is located on the bottom of the

scooter near the front wheel. Products with an oval sticker next to the serial number with a "V" followed by a letter (example VE, VF, VG etc.) are not included in the recall. The product was sold by authorized retailers nationwide and online from October 2007 through September 2008 for about \$100.

**PROBLEM:** The undersides of the foot platforms can have sharp edges, posing a laceration hazard to children.

**REMEDY:** Parents should immediately stop children from using the product. Do not return the product to the retailer. Contact Razor at **(800) 314-9870** or visit <u>www.razor.com/recall</u> for a set of free replacement foot platforms.

**PRODUCT/FIRM:** Toy Police Cars by TCB Imports **BRAND/MODEL:** This recall involves toy police cars with a friction. When the toy car is pushed forward, the



car builds momentum. When released, the car moves forward on its own. The cars were sold in red/white and purple/white color combinations. The cars measure 8 inches by 4 inches by 4 ½ inches. Item number TF820 is printed on the product's packing. This product was sold at Dollar and discount stores nationwide from May 2008 through August 2008 for about \$1.

**PROBLEM:** The red paint on the toy cars contains excess levels of lead, violating the federal lead paint standard.

**REMEDY:** Consumers should immediately take this toy away from children and return it to the store where purchased for a refund. For additional information, contact TCB Imports, Inc. at **(888) 674-5497** or visit <u>www.tcbimports.com</u>.

**PRODUCT/FIRM:** Toy Boats by Buzz's Boatyard **BRAND/MODEL:** This recall involves two toy models of tin Pop Pop toy boats. Models included in the recall are



the 13 inch "Titanic" and the "Hut" Pop Pop boats. This product was sold at Buzz's Boatyard's Web site (www.buzzboats.com) from

April 2007 to November 2007 for between \$3 and \$12. **PROBLEM:** The paint on the recalled toy boats contains excess levels of lead, violating the federal lead paint standard.

**BRAND/MODEL:** These cars were sold in a variety of colors. The model name and numbers are located on the body of the

vehicle or on the retail packaging. These products were sold by authorized dealers nationwide from March 2007 through April 2008 for between \$260 and \$400.

**PROBLEM:** The remote control unit can lose its signal, causing the toy vehicle to lose control, posing a risk of injury to the user or bystander.

**REMEDY:** Consumers should immediately stop using the product and contact Redcat Racing of (602) 454-

**6445** or visit <u>www.redcatracing.com</u> for information on receiving a replacement car.

**PRODUCT/FIRM:** Wooden Puzzles, Infant Rattles, Pacifier Holders, and Stroller Toys by Habermaass Corp. Inc.

**BRAND/MODEL:** The following toys are included in this recall: Triolino Puzzle (lady bug puzzle is 7 inches x <sup>1</sup>/<sub>2</sub> inch thick); LUCY Clutching Toy rattle (hearts have



mirrors and prisms. The rattle is about 4 inches in diameter); Little Heart Clutching Toy Rattle (Heart has mirror and is about 3 ½ inches in diameter); Pixie's World (2.5" rattle with mushroom, flower, person and house with mirror); Belinda Clutching Toy Rattle

Triola Rattle (4" triangle with two flowers and round corner.) Tri Rattle (4" triangle shape with squeaker, bell and mirror.) Speedy Rattle (Wooden car about 4.5" Lx 3" H with squeaker in back and mirror on car hood.); Little Hearts Stroller Toy (18" prism-chain with ten various size wooden hearts.); Discovery Balls (set contains 1 orange, 1 red, 1 blue and on bicolor blue/yellow ball. Red ball contains three small mirrors.); Discovery Ball with Rattle (Blue/Yellow round wooden ball with small mirror.) These products were sold at specialty toy stores nationwide and at specialty online retailers from January 2002 through August 2008 for between \$10 and \$35.

**PROBLEM:** The wooden rattles, pacifier holders and stroller toys contain small pieces including glued on mirrors and/or prisms that can detach, posing a choking hazard to infants. The head of the ladybug puzzle pieces also poses a choking hazard to infants. The head of the ladybug puzzle pieces also poses a choking hazard.

**REMEDY:** Consumers should immediately take the recalled puzzles, rattles, pacifier holders and stroller toys away from children and contact Habermaass at **(800) 468-6873** or visit <u>www.HABusa.com/safety</u> to receive a free replacement product or a full refund.

**PRODUCT/FIRM:** LaJolla Boat Bed and Pirates of the Caribbean Twin Trundle Beds by Bayside Furnishings (a division of Whalen<sup>™</sup>)

BRAND/MODEL: Tr

This recall involves two styles of Bayside youth beds: the LaJolla Boat Bed and the Pirates of the Caribbean Twin Trundle Bed. The preassembled toy chests are designed in the shape of a ship or boat's "bow" and attached to the beds as a footboard. The

LaJolla Boat Bed toy chest has a hardwood top and white wood base with blue stripe. The Pirates Boat Bed toy chest has a hardwood top, wheel shape and brown wood base with decorative carvings. These products were sold at Costco and furniture retail stores nationwide and Costco.com from January 2006 through May 2008 for between \$700 and \$1,400.

**PROBLEM:** The lid supports on the toy chests fail to prevent the lid from closing too quickly, posing an entrapment and strangulation hazard to young children.

**REMEDY:** Consumers should immediately stop children from using the recalled toy chest and contact Bayside at (877) 494-2536 or visit <u>www.baysidefurnishings.com</u> for instructions on receiving a free repair kit with replacement lid supports.

**PRODUCT/FIRM**: Hooded Sweatshirts by Raw Blue Sportswear

**BRAND/MODEL:** The Raw Blue hooded sweatshirts were sold in three styles: smack print, kapow print and



s: smack print, kapow print and comic magazine print and various colors. The sweatshirts have style numbers 7FT5655, 7FT5455, and 7FT5515. Style numbers are printed on the garment's sales tag. These products were sold at TJ Maxx, Mega Trends, Moonstone Shirts and MP Trading stores

nationwide from July 2007 through December 2007 for between \$30 and \$40.

**PROBLEM:** The sweatshirts have a drawstring through the hood which poses a strangulation hazard to young children.

**REMEDY:** Consumers should immediately remove the drawstrings from the sweatshirts to eliminate the hazard. Consumers can return the garment to the place of purchase or Raw Blue Sportswear for a refund. For additional information, contact Raw Blue Sportswear at **(800) 638-1537**.

**PRODUCT/FIRM**: Sun Smarties<sup>™</sup> Children's Board Skirts by Chelsea & Scott Ltd.

**BRAND**/**MODEL:** The Sun Smarties<sup>™</sup> board skirts are peach microfiber with an embroidered flower accent and back pocket. Item number 13926 HIBI is printed on the

care label inside the back of the waistband. The skirts



were sold in girls sizes 12 months to 4T. The skirts have six grommets, four on the front of the waistband and two on the back pocket. This product was sold exclusively at www.onestepahead.com

from May 1, 2008 through May 9, 2008 for about \$15. **PROBLEM:** The paint on the grommets of the skirts contains an excess level of lead, violating the federal lead paint standard.

**REMEDY:** Consumers should immediately take these skirts away from young children and return them to Chelsea & Scott Ltd to receive a free replacement skirt or refund. Consumers will be sent a postage paid envelope from Chelsea & Scott Ltd. For additional information, contact Chelsea & Scott Ltd at (866) 271-4536 or www.onestepahead.com.

**PRODUCT/FIRM:** Taggies<sup>™</sup> Strollin' Along Stroller Activity Bars by International Playthings Inc.

**BRAND/MODEL:** This recall involves the Taggies<sup>™</sup> Strollin' Along stroller activity bars. The multicolored



fabric, and plastic activity bars feature a yellow giraffe, a purple hippo and blue elephant attached to a 12" long elliptical base with straps that attach to a stroller. The Taggies<sup>™</sup> and Earlyears<sup>®</sup> logos are located on woven and satin labels sewn

**PROBLEM:** The shiny material on the elephant's ear on the activity bar can detach, posing a choking hazard to young children.

**REMEDY:** Consumers should immediately stop using the activity bars and contact International Playthings at (800) 445-8347 or visit <u>www.intplay.com</u> for a free replacement toy.

**PRODUCT/FIRM:** Phil & Teds e3 Single Buggy, e3 Twin Buggy and sport v1 Single Buggy Strollers by Regal Lager Inc.

BRAND/MODEL: The recalled single strollers all have



metal frames with three wheels, a cloth seat and canopy. The twin strollers have a metal frame with four wheels, side-by-side cloth seats and double sun canopies. The strollers were sold in a variety of colors including red, orange, green, black, charcoal, and navy. The Phil & Ted logo is located on the crotch piece of the harness. This product was sold at baby furniture and baby

products stores nationwide from August 2003 through August 2008 for between \$400 and \$650.

**PROBLEM:** The stroller's hinge locking mechanism poses a laceration hazard to the user folding and unfolding the strollers.

**REMEDY:** Consumer should stop using the stroller immediately and contact Regal Lager at (877) 242-5676 or visit <u>www.regallager.com</u> to obtain a free hinge cover repair kit and instruction.

**PRODUCT/FIRM:** Children's Hooded Sweatshirts and Jackets by Orioxi International Corp.

**BRAND/MODEL:** The recalled garments were sold in children's sizes small, medium and large in the following



colors: white, ivory, red, black, navy, brown, green, charcoal, blue, and pink. "BAC" is printed on the sewn-in tag on some of the garments. "Breckenridge", "Keystone", "Jackson Hole", "Vali", "Steamboat", and "Mackinac Island" is printed on the front of the garments.

This product was sold at "Shirt off My Back" retail stores located in Colorado, Wyoming, and Michigan from September 2005 through May 2008 for between \$20 and \$30.

**PROBLEM:** The sweatshirts and jackets have a drawstring through the hood which poses a strangulation hazard to young children.

**PRODUCT/FIRM:** Children's Metal Water Bottles by Pottery Barn Kids

**BRAND/MODEL:** The metal water bottles are about 9 inches tall and have a black rubber pull up sip top. The





# NEWS from the CPSC

Televisions, chests, armoires, and appliances are found in almost every room in your home. However, these items can tip over, and crush children causing injury or death. The Consumer Product Safety Commission reports that in the last two years there have been approximately 40 reports of television or furniture related tip-over deaths.

These deaths and injuries frequently occur when children climb onto, fall against or pull themselves up on television stands, shelves, bookcases, dressers, desks, chests and stove oven doors. Televisions placed on top of furniture can tip over and cause a child to suffer traumatic and sometimes fatal injuries.

To help prevent tip-over hazards, the U.S. Consumer Product Safety Commission recommends the following safety tips:

- Verify that your furniture is stable on its own.
- For added security, anchor all entertainment units, television stands, bookcases, shelving and bureaus to the wall of floor using appropriate hardware, such as brackets, screws, or toggles.
- Place televisions on sturdy furniture appropriate for the size of the television or on a low-rise base.
- Push the television as far back as possible from the front of its stand.
- Place electrical cords out of a child's reach, and teach children not to play with the cords.
- Remove items, such as toys and remote controls, from the top of the television and furniture that may tempt kids to climb.

Tip-over related deaths continue to be a problem, but these tragedies can be prevented by taking the above precautions.
