TOY PRODUCT RECALLS

PRODUCT/FIRM: Flower and Insect Painted Wooden Beads by S&S Worldwide Inc.

BRAND/MODEL: The children's painted wooden beads are in the shapes of insects and flowers. They were sold in assorted colors and designs and measure about one



inch in size. They were sold in $\frac{1}{2}$ lb. bags. Model number BE 1190, "S&S Worldwide Inc" and "Made in China" is

located on the bag of beads. This product was sold in S&S Worldwide catalog and on the firm's website at <u>www.ssww.com</u> from March 2008 through February 2010 for about \$20 per ½ lb bag.

PROBLEM: The paint on the children's wooden beads contains excessive levels of lead, violating the federal lead paint standard.

REMEDY: Consumers should immediately take the recalled beads away from children and contact S&S Worldwide for a full refund or replacement product. S&S Worldwide is directly contacting consumers who purchased the beads to inform them of this recall. PRODUCT/FIRM: Bicycle Bells by Do It Best Corp and Boutou Baite Bike Bell Co. Ltd.

BRAND/MODEL: This recall involves children's bicycle bells. The bells are red, black, and white and has "I ♥



My Bike" printed on the top. The green and white packaging reads "bike bell" and "\$1." This product was sold at Dollar Stores and Do It Best Hardware stores nationwide from August 2008 through August 2009 for about \$1.

PROBLEM: The red paint on the bicycle bells contains excessive levels of lead, violating the federal

REMEDY: Consumers should immediately remove the bicycle bells from any bike and return them to the store where purchased for a refund. For additional information, contact Do It Best Hardware at (877) 326-8954 or visit <u>www.doitbest.com</u>.

PRODUCT/FIRM: BigBox Hockey Sets by Sportime **BRAND/MODEL:** This recall involves all sets of BigBox Hockey, each consisting of six boards, measuring 6' long by 10" tall. The boards come in six colors: red, orange,



yellow, green, blue and violet. The boards can be assembled together to create a contained playing area for children's floor hockey. This product was

sold through Sportime's catalog and online at <u>www.sporttime.com</u> from November 2006 through October 2009 for between \$147 and \$269.

PROBLEM: The surface coating on the boards, which are assembled together to form the floor hockey playing-field, contain excessive levels of lead violating the federal lead paint standard.

REMEDY: Consumers should immediately take the recalled product away from children and contact Sportime at (888) 388-3224 or visit www.schoolspecialty.com to obtain a full refund.

PRODUCT/FIRM: Carolina Function Generator Kits by Carolina Biological Supply Co.

BRAND/MODEL: This recall involves the Carolina Function Generator Kits that are mathematical function teaching aids. The kit consists of a yellow plastic lid, leg stands, a base and whiteboard cards. The yellow lids have two slots labeled "IN" and "OUT" and are embossed with the name "Carolina" and "Lid" in raised

letters. This product was sold through Carolina's

catalogs and online at <u>www.carolina.com</u> nationwide and directly to schools from February 2009 through January 2010 for about \$34. They were also sold with "Math Out of the Box Kits" for between \$780 and \$2930.

PROBLEM: The yellow lids in the kits contain excessive levels of lead. Lead is toxic if ingested by young children and can cause adverse health effects.

REMEDY: Consumers should immediately take the recalled kits away from children and contact Carolina Biology Supply at (877) **316-1848** or visit **www.carolina.com** to obtain a free replacement kit. The firm is directly contacting purchasers of the educational kits.

PRODUCT/FIRM: Pull-A-Long Friends Toucan[™], Pull-A-Long Friends Alligator[™], and Pull-A-Long Friends Sharky[™] by Manhattan Group LLC

BRAND/MODEL: This recall involves three types of pull-toys: Pull-A-Long Friends Toucan[™] with lot code 210720GB, Pull-A-Long Friends Alligator[™] with lot code



210750GB, and Pull-A-Long Friends Sharky[™] with lot code 210530GB. The Toucan has a large yellow and black beak and blue striped wings. The alligator is green and has a red ridge on its back and red wheels with yellow polka dots. The shark has blue

swirls painted on its wheels and an orange wooden fish on the pull string. The lot code is printed on the bottom of the toy. This product was sold at gift and specialty stores nationwide, online and through catalogs from September 2009 through January 2010 for about \$22.

PROBLEM: The toy has wooden components that can break or come loose, posing a choking or an aspiration hazard to young children.

REMEDY: Consumers should take the toys away from young children immediately and return them to the store where purchased for a refund or a replacement toy. For additional information, contact Manhattan Group at **(800) 541-1345** or visit www.manhattantoy.com.

PRODUCT/FIRM: Tiny Tink and Friends Children's Toy Jewelry Sets by Playmates Toys

BRAND/MODEL: This recall involves charms sold with the Tiny Tink and Friends toy jewelry sets. The charm is attached to a cord using a metal ring and cylinder and



included with the sets as a separate accessory that children can attach to the toy necklace, bracelets or key chain. The toy jewelry sets containing the charm accessory were sold in a variety of styles: Tinker Bell's Lil' Tinker Bracelets # 74634 and # 74641; Rosetta's Rosebud Key Chain # 74631; and Silvermist's Water Necklace #

74632. Charms that have plastic instead of metal rings and cylinders are not included in this recall. This product was sold at retailers nationwide from November 2008 through November 2009 for between \$6 and \$8. **PROBLEM:** A cylindrical metal connector on a charm can contain levels of total lead in excess of 300 ppm, which is prohibited under federal law.

REMEDY: Consumers should immediately take the charm and cord away from children, discard the items, and contact Playmates Toys at **(888) 810-1133** or visit **www.playmatestoys.com** for a replacement charm accessory.

PRODUCT/FIRM: Special Forces and Police SWAT Toy Gun Sets by Dollar General

BRAND/MODEL: This recall includes a Special Forces Weapons and Accessories Set and a SWAT Police Play



Equipment Set. Each set includes two toys guns and related accessories. The number 49JQH09 is printed on the right side of the larger gun included in the recalled sets. This product was sold at Dollar

General Stores in 35 states from September 2009 through October 2009 for about \$5.

PROBLEM: The orange tips located at the end of the toy guns' barrels, which are designed to distinguish them from real guns, can easily be removed from the barrels, posing choking hazard to children.

REMEDY: Consumers should immediately take the recalled toy gun away from children and return them to any Dollar General for a full refund or a replacement product. For additional information, contact Dollar General Corp. at (800) 678-9258 or visit www.dollargeneral.com.

PRODUCT/FIRM: Discovery Kids[™] Animated Marine and Safari Lamps by Innovage LLC

BRAND/MODEL: This recall involves the Discovery Kids[™] Animated Marine Lamp with model number 167121 or 1628626 and the Animated Safari Lamp with



model number 1627124 or 1628626. All models have batch numbers beginning with "2". The decorative lamps are silver in color and feature rotating firms with marine or safari scenes. "Discovery Kids" is printed on the

front top left corner. The batch number is an 11 digit number located on the bottom of each unit. The model number can be found on the bottom of the packaging. This product was sold at mass merchandisers, department, drug and hardware stores nationwide, online and through direct sales from July 2009 through January 2010 for about \$10.

PROBLEM: There is a defect in the lamp's printed circuit board which can cause an electrical short, posing a fire and burn hazard to consumers.

REMEDY: Consumers should immediately stop using the lamps, and contact Innovage at **(888) 232-1535** or visit <u>www.lamprecall.org</u> for information on returning the product for a full refund.

PRODUCT/FIRM: Danbar Knight Hawk Toy Helicopters by RadioShack Corp.

BRAND/MODEL: This recall involves Danbar Toys Knight Hawk 3D remote control helicopters. The helicopter can be identified by model number 006047



marked on the back of the controller and the Knight Hawk 3D logo on the front the controller. The product was sold at RadioShack at catalog number 600-0566

(60-566) for ages 8 and up. This product was sold at RadioShack stores, RadioShack dealer franchise stores nationwide and at <u>www.radioshack.com</u> from October 2009 through November 2009 for about \$60.

PROBLEM: The battery housing under the helicopter canopy can overheat while charging, posing a fire hazard.

REMEDY: Consumers should immediately take the recalled helicopters away from children and return the toy to the nearest RadioShack at (800) 843-7422 or visit <u>www.radioshack.com</u> store for a full refund.

PRODUCT/FIRM: Nature Wonders HD Pinto Horse Toy Figures by Blip Toys

BRAND/MODELS: This recall involves the Nature Wonders HD pinto horse toy figures with model number 92093. The plastic horse is white with brown spots and



measures about 4 inches tall. The model number and "Nature Wonders HD" are printed on the retail tag wrapped around the horse's leg. This product was sold by Wal-Mart stores nationwide from January 2009 through July 2009 for about \$4.

PROBLEM: The surface paint coating on the horse contains excessive levels of lead, violating the federal lead paint standard.

REMEDY: Consumer should immediately take the recalled toys away from children and contact Blip Toys at **(888) 405-7696** or visit <u>www.bliptoys.com/recall</u> to receive a free replacement toy.

PRODUCT/FIRM: "Big Rex and Friends" Cloth Books by St. Martin's Press LLC

BRAND/MODEL: This recall involves "Big Rex and Friends" cloth books. The book has a black and white striped border with a red dinosaur on the cover. The



ith a red dinosaur on the cover. The words "Big Rex and Friends" are printed on the cover. ISBN 031249260X or 9780312492601 is printed on the back of the book. This product was sold at Barnes & Noble, Toys "R" Us, Amazon, Borders and other bookstores and retailers

nationwide from May 2004 through October 2009 for about \$9.

PROBLEM: A red plastic dot sewn in the books contains high levels of lead. Lead is toxic if ingested by young children and can cause adverse heath effects.

REMEDY: Consumer should immediately take the recalled book away from children and contact St. Martin's Press at (800) 347-9411 or visit

www.priddybooks.com/recall for instruction on returning the book for a full refund.

PRODUCT/FIRM: Military toy figures by Jide Trading, Inc.

BRAND/MODEL: The mini military toy set is packaged on a blister card and include a male military figure about



four inches in height with various accessories. This product was sold by Dollar Stores and other discount stores from November 2008 to April 2009.

PROBLEM: The surface paint on the toy contains excessive levels of violating the federal lead paint standard.

REMEDY: Consumers should immediately take the recalled toys away

from children and contract Jide Trading at **(866) 544-7822** or visit <u>www.jidetrading.com</u> for a full refund or replacement toy.

PRODUCT/FIRM: Children's Metal Necklaces by FAF Inc.

BRAND/MODEL: The recalled jewelry is shaped as a metal crown or frog and the crown or frog pendant is on



a metal link chain necklace in a crown hinged box. The packaging has the words "The Princess and the Frog" on it and contains the following models numbers and UPC codes: Crown Model # 4616-4187 and Frog

Model # 4616-4190. This product was sold exclusively at Wal-Mart retail stores nationwide from November 2009 through January 2010 for \$5.

PROBLEM: The recalled necklaces contain high levels of cadmium. Cadmium is toxic if ingested by young children and can cause adverse health effects.

REMEDY: Consumers should immediately take the recalled jewelry away from children. Consumers should return the recalled jewelry to any Wal-Mart store for a full refund or a free replacement product. For additional information, contact FAF Inc. at (800) 949-3311 or visit www.faf.com.

PRODUCT/FIRM: Wind Chime Toys by Tiny Love Inc.

BRAND/MODEL: This recall involves wind chime toys sold separately and with Gymini Kick & Play Activity Gym and Tiny Smarts Gift Sets. The toy produces the



sound of a wind chime. "Tiny Love" is printed on a tag on the toy. The following names and item numbers are included in this recall: Baby Wind Chime # 493, Baby Wind Chime-Ocean # 593, Tiny Smarts-Baby Bunny # 512, Wind Chime-Duck # 811, Wind Chime-Louie # 516, Wind

Chime-Ella # 517, and Tiny Smarts Gift Set # 539. Wind chimes sold with other Tiny Love Activity Gyms are not included in this recall. This product was sold at Toys "R" Us, Wal-Mart, Target, Buy Buy Baby, and TJ Maxx stores nationwide from February 2002 through February 2010 for about \$8 separately, \$22 for the Tiny Smarts Gift Sets and \$70 with the Gymini Kick & Play Activity Gvm.

PROBLEM: The wind chime toy can be pulled apart exposing sharp metal rods, posing puncture and laceration hazards to a baby.

REMEDY: Consumers should immediately take the recalled wind chimes from babies and contact Tiny Love at (888) 791-8166 or visit www.tinylove.com to receive a free replacement toy.

CHILD PRODUCT RECALLS

PRODUCT/FIRM: Hooded Sweatshirts by Baycreek Inc. BRAND/MODEL: This recall involves Attitude Gold children's hooded sweatshirts in size small, medium,



large and extra large. The sweatshirts were sold in beige, blue, charcoal gray and black and have a random distress design. Style number ZZJ-2J, ZZJ-01J, ZZJ-04J or ZZJ-5J is printed on the hangtag. This product was sold at Burlington Coat Factory and Modecraft Fashions stores

nationwide from October 2008 through June 2009 for about \$25.

PROBLEM: The sweatshirts have a drawstring through the hood which can pose a strangulation hazard to children.

REMEDY: Consumers should immediately remove the drawstrings from the sweatshirts to eliminate the hazard or return the garment to either place of purchase or to Baycreek for a full refund. For additional information, call Baycreek at (212) 279-2777.

PRODUCT/FIRM: Girls' Hooded Sweaters with Drawstrings by Children's Apparel Network, Ltd.



BRAND/MODEL: The hooded sweaters were sold as part of a 3-piece set with knit shirt and cordurov pants. The airls' has acrylic sweater flower appliqués and embroidery. Α Young Hearts label in the neck seam has RN # 16435. The sweaters were sold in sizes 2-4T

and 4-6X. This product was sold at Burlington Coat Factory, Pamida and Ross Stores nationwide from June 2008 through November 2008 for about \$15.

PROBLEM: The hooded sweaters have a drawstring at the neck which can pose a strangulation hazard to children

REMEDY: Consumers should immediately remove the drawstring from the sweaters to eliminate the hazard, or return the garment to the place of purchase for a full refund. For additional information, contact Children's Apparel Network at (800) 919-1917.

PRODUCT/FIRM: Evenflo Top-of Stair™ Plus Wood Gates by Evenflo Co. Inc.

BRAND/MODEL: The recall involves Evenflo models 10502 and 10512 Top-of-Stair Plus Wood Gates made from October 2007 through July 2009. The model number can be found on the bottom rail. No other Evenflo model numbers or gates are affected by this



recall. This product was sold at Toys "R" Us, Burlington Baby Depot, Kmart and other juvenile product and mass merchandise retailers nationwide in the U.S. and Canada. on the Web at Amazon.com and other online

retailers from October 2007 through March 2010 for about \$40.

PROBLEM: The slats on the gate can break or detach, posing a fall hazard to children.

REMEDY: Consumers should stop using the recalled gate and contact Evenflo at (800) 233-5921 or visit www.safety.evenflo.com to obtain a free newer model 10503 or 10513 Top-of-Stair™ Plus Wood replacement gate.

PRODUCT/FIRM: Posey, Lily, Rose and Daisy Girls' Ski Jackets by Sport Obermeyer, Ltd. **BRAND/MODEL:**

The recalled girls' jackets have



drawstring at the waist, sold in sizes 1 to 8 and the names and corresponding style numbers are: Lily # 91549, Rose # 91552, Daisy # 91555, Posey # 91558. The style number is printed on the tag inside the neck of the jackets. This product was sold at various

boutique and ski/sport retailers from July 2009 through February 2010 from \$90 to \$140.

PROBLEM: The jackets have a drawstring at the waist which can pose an entrapment hazard to children.

REMEDY: Consumers should immediately remove the drawstrings from the jackets to eliminate the hazard or return it to Sport Obermeyer, Ltd for a full refund. For additional information, contact Sport Obermeyer at (800) 778-5465 or visit www.obermeyer.com.

PRODUCT/FIRM: North-Sportif Hooded Jackets and Reversible Vests by North-Sportif Inc.

BRAND/MODEL: This recall involves boys' black hooded jackets with a belt and an elastic drawstring at



the neck. "North Sportif" is printed on the jacket's belt. The recalled vest is black and blue and is reversible. The vest has a drawstring around the waist. The garments were sold in sizes small (8-10) and medium

(12-14). Both garments have a tag on the neck that reads North Sportif Urban Expedition. This product was sold exclusively at Burlington Coat Factory stores nationwide from October 2002 through January 2010 for about \$13.

PROBLEM: The jackets have a drawstring through the hood and the vests have a drawstring through the waist which can pose strangulation and entanglement hazard to young children.

REMEDY: Consumers should immediately remove the drawstrings from the garment to eliminate the hazard or return the garment to Burlington Coat Factory at (212) 643-9730 or visit <u>www.burlingtoncoatfactory.com</u> for refund or credit.

PRODUCT/FIRM: Boys' Hooded Jackets by Ten West Apparel

BRAND/MODEL: This recall involves Ten 1 West boys'



jackets with a drawstring through the hood. They were sold in size 10/12 and are black cotton with a white fleece lining. "TEN 1 WEST" is printed on a hang tag on the center of the back neck. This product was sold exclusively at Burlington

Coat Factory stores nationwide from November 2006 through September 2009 for about \$12.

PROBLEM: The children's jackets have drawstring through the hood which can pose a strangulation hazard to children.

REMEDY: Consumer should immediately remove the drawstring from the jacket to eliminate the hazard or return the garment to Burlington Coat Factory or to Ten West Apparel for a full refund. PRODUCT/FIRM: Scooby Doo, Tweety and Batman Fork and Spoon Sets by Peachtree Playthings

BRAND/MODEL: This recall involves the Scooby Doo,





PROBLEM: The middle two prongs of the plastic fork can detach, posing a choking hazard to children.

PRODUCT/FIRM: Papyrus Brand Greeting Cards with bracelets by Schurman Fine Papers

PROBLEM: The surface paint coating on the bracelets sold with greeting cards contain excessive levels of lead violating the federal lead paint standard.

REMEDY: Consumers should immediately stop using the bracelets and contact Schurman Fine Papers (888) 990-9095 for instructions on how to receive a refund.

PRODUCT/FIRM: 21 Pro USA Children's Pullovers and Hoodies by New Mode Sportswear

BRAND/MODEL: This recall involves children's hooded pullover and zip hooded sweatshirts in sizes S-XL. They were sold in black, navy blue and heather gray. Brand



name "21 Pro USA" Sportwear and RN#92952 are printed on a label sewn into the neck of the sweatshirts. This product was sold at various T-shirt outlets and swap meets on the West Coast from January 2006 through July 2006 for about \$6.

PROBLEM: The children's sweatshirts have a drawstring through the hood which can pose a strangulation hazard to children.

REMEDY: Consumers should immediately remove the drawstring from the sweatshirts to eliminate the hazard or return the garment to the place of purchase or to New Mode Sportswear for a full refund. For additional information, contact New Mode Sportswear at (888) 899-0888 or visit www.21prousa.com.

PRODUCT/FIRM: Children's Jackets with Drawstrings

BRAND/MODEL: This recall involves children's hooded nylon jackets in sizes XXS-XL (2T-15) and in various

PROBLEM: The children's jackets have drawstrings through the hood which can pose a strangulation hazard to children

REMEDY: Consumers should immediately remove the drawstrings from the jackets to eliminate the hazard or return the jackets to their place of purchase or toe GTM Sportswear for a full refund. For additional information, contact GTM Sportswear at (800) 437-9560 or visit www.gtmsportswear.com.

PRODUCT/FIRM: Britax "Blink" Umbrella Strollers by Britax Child Safety, Inc.

BRAND/MODEL: This recall involves all Britax "Blink" single umbrella strollers. "Blink" is printed on the metal



frame on both sides of the stroller, below the hand grips. The recalled "Blink" strollers have model numbers U261813. U261814, U261815, U261816, U261813. U271813. U271817 and U271815 and were manufactured between May 2009 and September 2009. The model

number and manufacturing dates can be found on a white label on the stroller frame, near the bottom of the stroller basket. This product was sold at Buy Buy Baby, other juvenile product and mass merchandise retailers nationwide in the U.S. and Canada and on the Web at www.babiesrus.com www.Amazon.com, and www.Target.com and www.Diapers.com from July 2009 through February 2010 for about \$150.

PROBLEM: The stroller's hinge mechanism poses a fingertip amputation and laceration hazard to children when the consumer is unfolding/opening the stroller.

REMEDY: Consumers should immediately stop using the recalled strollers and contact Britax at (888) 427-4829 or visit www.BlinkRecall.com to receive free stroller hinge covers.

PRODUCT/FIRM: Allreds Design Baby Bracelets and Pacifier Clips by Allreds Design dba Hidden Hollow Beads

BRAND/MODEL: This recall includes Allreds Design brand baby bracelets and pacifier clips. The bracelets



are sold in size 0-6 months, 1-4 years, and 4-8 years of age. The baby bracelets and pacifier clips have crystal and plastic beads in various colors with a metal clasp. This product was sold by resale stores, consignment retailers nationwide and on eBay from June

2008 through December 2008 for about \$5.

PROBLEM: The recalled bracelets and pacifier clip clasps contain high levels of lead. Lead is toxic if ingested by young children and can cause adverse health effects.

REMEDY: Consumers should immediately take the recalled bracelets and pacifier clips away from children and contact Allreds Design at (866) 695-3551 or visit www.hiddenhollowbeads.com for instructions on how to receive a replacement bracelet or pacifier clip.

PRODUCT/FIRM: Girl's Hooded Sweatshirts with Drawstring by Bobens Trading Co. Inc.

BRAND/MODEL: The recall involves "Old Skool" girls' hoodie sweatshirts with long and short sleeves in sizes S-XL and in a variety of colors and designs. The neck seam label reads "Old Skool" and includes the garment size. The recalled style numbers GC5910, GV105, GV105, GV104 and GF254,

were printed on the hang tags along with the price. The product sold at Burlington Coat Factory stores nationwide from November 2007 to September 2009 from about \$8.00 to \$20.00.

PROBLEM: The hooded zip sweatshirts have a drawstring through the hood which can pose a strangulation hazard to children.
